

**LAUNDRY GEL FOR WHITE FABRICS** – concentrated laundry detergent containing active oxygen and effective enzymes that penetrate deep into fabric fibers. Effectively removes stains and dirt while protecting laundry from greying and maintaining its bright whiteness.

**INSTRUCTIONS FOR USE:**

**Sorting Laundry:**

Sort fabrics according to the recommended washing temperatures indicated on the care labels (including washing at 95 °C, which is suitable for durable textiles such as towels, bed linens, or kitchen cloths requiring maximum hygiene).

**Measuring Detergent:**

Use a measuring cup to measure the appropriate amount of detergent. The amount depends on the level of soiling and the hardness of the water.

**Preparing the Washing Machine:**

Place the laundry into the drum of the washing machine. Pour the laundry gel into the machine's detergent dispenser or use a dosing ball and place it directly in the drum.

**Setting the Washing Machine:**

Select the appropriate washing program and set the temperature according to the instructions on the care labels (e.g., 30 °C for delicate fabrics, 60 °C for white cotton laundry, 95 °C for textiles requiring intensive cleaning).

**Starting the Wash Cycle:**

Start the washing machine and allow the wash cycle to complete.

**After Washing Care:**

Remove the laundry from the washing machine promptly to avoid dampness. If necessary, use a dryer in accordance with the instructions on the care labels.
